2. Learned P.O. files affidavit in reply on behalf of respondent no.1. It is taken on record. Copy thereof has been served on the other side.

3. Learned P.O. prays for time for filing affidavit in reply on behalf of the respondent nos.2 and 3.

4. Grievance of the applicants is similar to that of in O.A.No.368/2019 (of Mumbai) filed by Amruta Suresh Yadav.

5. Learned Advocate for the applicants prays for interim relief that applicants be called for viva voce arguing that:

(a) The impugned G.R dated 19.12.2018 results in permitting women candidates selected in the process of horizontal reservation to migrate

based on the principle of migration in vertical reservation.

(b) This act of executive is either based on erroneously drafted G.R dated 19.12.2018 or due to erroneous interpretation of said G.R.

(c) Act of the Respondents is wrong being in violation of dictum of Hon'ble Supreme Court conferred in para 513 & 514 read with para 812 in the reported judgment of Constitution Bench of Hon'ble Supreme Court in Indra Sawhney Vs. Union of India 1992 Supp (3) SCC 217, as further elaborated and illustrated in subsequent judgment of Hon'ble Supreme Court in Anil Kumar Gupta Vs. State of U.P (1995) 5 SCC 173 through para 15 thereof and in case of Rajesh Daria Vs. Rajasthan Public Service Commission (2007) 8 SCC 785 as well in the judgment of High Court of Judicature of Rajasthan at Jaipur in accompanying group of Writ Petitions in S.B. Civil Writ Petition No.11119/2012, Laxmi Kanwar & Anr Vs. State & Ors, through last four

paragraphs of the judgment appearing at page 30 onwards of the judgment on record at page 650 onwards.

6. Hence, the learned advocate for the applicants argues that:-

A candidate belonging to any class of vertical reservation to which the candidate may be entitled, is entitled to be arrayed in open merit, according to the order of merit. However, the same rule permitting migration does not apply whenever a women candidate applies in horizontal reservation in a particular class of vertical reservation, for shifting/migrating in the open women category by applying the principles of open competition.

7. The submission of applicant recorded in foregoing sub paras appears to be well founded on the basis of Judgment cited by learned advocate for the applicant.

8. Hence, this Tribunal is satisfied that the applicant has made out a case for grant of ex-parte

ad-interim relief by way of mandatory order against the Respondents.

9. Hence, for same reasons, as in O.A.No.368/2019 (of Mumbai) aforesaid, ad-interim ex-parte order is passed and respondents are directed as follows:

(a) Applicants be called and be interviewed and be considered for the post of Taluka Agriculture Officer, Agriculture Service Group-B as well as in Agriculture Officer, Group-B Junior and be provisionally included in merit list.

(b) Fate of applicants as to final selection would be decided at the admission hearing after receiving affidavit in reply or subject to outcome of the present O.A.

(c) The list of selected candidates shall not be acted upon until further orders.
