3. Learned Advocate for the applicant has submitted that respondent no.2 has passed the impugned order and the appeal as provided under the Maharashtra Civil Services (Discipline & Appeal) Rules, 1979 ["MCS (D & A) Rules" for short] lies with the same authority. Therefore, applicant apprehends that no justice will be given to him in case he prefers the appeal before same authority, and therefore, the applicant has approached this Tribunal without availing remedy available to him under the MCS (D & A) Rules.

4. The suspension order issued under Rule 4 is an appealable order in view of Rule 17 of the MCS (D & A) Rules. Appellate authorities are provided in Rule 18 of

the MCS (D & A) Rules. Not only this but in view of the provisions of Rule 4(5) of the MCS (D & A) Rules, person aggrieved by the order can make representation before same authority or higher authority to which the authority is subordinate.

5. Abovesaid rules provide alternate remedy for challenging the suspension order. The applicant has not availed the alternate remedy available to him under the service rules. Since the applicant has not availed the alternate remedy available to him for redressal of his grievance, the O.A. cannot be admitted in view of S.20 of the Administrative Tribunals Act, 1985.

6. Since the application is not maintainable in view of S.20 of the Administrative Tribunals Act, the O.A.St.No.1910/2018 stands rejected. Case stands disposed of accordingly without any order as to costs.
