The deponent of the Affidavit-in-Reply and additional Affidavit Shri Saurabh A. Rao, the District Collector, Pune at least prima-facie appears to have been negligent in the matter of assisting this tribunal by way of the Affidavit-in-Reply.

I direct a show cause notice to issue to him asking him as to why a really prohibitive cost be not imposed on him for such a conduct in that manner. Meanwhile a copy of the document be placed on record during course of the day. The said deponent shall comply on the next date and this Part-Heard matter shall appear on board on 07.03.2017.
