

JUDGMENT

1. Heard Shri A.V. Bandiwadekar, the learned Advocate for the Applicant and Ms. S.P. Manchekar, the learned Chief Presenting Officer for the Respondents.
2. The Applicant is claiming retirement benefits on account of his retirement on superannuation. It is contention of the Applicant that he has been retired on 31.01.2012 on superannuation but he has not received retirement benefits and therefore he approached this Tribunal.
3. Learned Advocate for the Applicant has submitted that the Respondents have withheld the pensionary benefits of the Applicant and therefore he prays to grant the retirement benefits to the Applicant.
4. Respondents have filed short affidavit-in-reply stating that they have challenged the decision of this Tribunal in earlier O.A.No.119 of 2013 filed by the Applicant before the Hon'ble High Court by filing W.P.No.5501 of 2016 but same came to be dismissed on 21.07.2017. Thereafter the Respondents filed Review Petition (Stamp) Petition bearing No.31713 of 2017 in W.P.No.5501 of 2016 before the Hon'ble High Court but it came to be dismissed on 26.02.2018. Thereafter it was advised by the Government pleader to approach before the Hon'ble Apex Court and accordingly the case of the Applicant was submitted to the Law and Judiciary Department, Government of Maharashtra to seek advice as to whether the state can approach the Apex Court to prefer S.L.P. challenging the order of Hon'ble High Court.
5. Learned C.P.O. for the Respondents has submitted that as per the directions given by the Law & Judiciary Department, Respondents had approached Government Pleader in the Apex Court. The Government Pleader advised the Government not to file S.L.P. and therefore the case of the Applicant has been sent back for taking appropriate steps in the matter.
6. Learned Advocate for the Applicant has submitted that in view of the information given by the Respondents in affidavit-in-reply it is just to direct the Respondents to release retirement benefits of the Applicant as no Special Leave Petition has been filed by them before


the Hon'ble Apex Court and therefore he prayed to dispose of the O.A. with the said directions to the Respondents.

7. Learned C.P.O. for the Respondents has further submitted that Respondents will take appropriate decision in the matter regarding release of retirement benefits to the Applicant within four months. Therefore she prayed to pass the necessary order since the order passed in O.A.No.119 of 2013 became final and therefore the Applicant is entitled to get retirement benefits.

8. The Respondents in paragraph no.6 of the affidavit-in-reply contented that they will take appropriate decision regarding release of retirement benefits to the Applicant and therefore they prays to grant some time.

9. Learned C.P.O. for the Respondents has made submission that within stipulated time the Respondents will take appropriate decision in that regard. In view of this it is just to dispose of the O.A. with directions to the Respondents to take appropriate decision granting pensionary/retirement benefits to the Applicant within three months from today.

10. Original Application is disposed of accordingly. No order as to costs.
