1. Heard Shri A.S. Shelke, learned Advocate for the applicants and Shri M.S. Mahajan, learned Chief Presenting Officer for respondents in all these matters.

2. The issue involved in the present O.As. is regarding cut-off-date for regularization of daily wages workers in the Forest Department vide G.R. dated 16.10.2012 and in Social Forestry Department vide G.R. dated 31.10.2013. In these, G.R's. period to ascertain eligibility was 01.11.1994 to 30.06.2004, whereas, the services were regularized w.e.f. 01.06.2012. The learned Advocate for the applicants submits that the date of regularization is choosen arbitrarily.

3. The learned Advocate for the applicants has also drawn attention to G.R. dated 19.10.1996, wherein, the applicants who fulfilled the eligibility on 01.11.1994 were regularized w.e.f. 1.11.1994 only. He has also submits that in case, the regularization would have been effected from 01.06.2004, they would have been benefited from the than existing pension scheme.

4. Replies have been filed on behalf of all the respondents, in some of the cases, while, short accommodation have been sought in some cases. The replies filed in the cases have been perused. The submissions of the respondents are silent about the cut-off-date. It is submitted that once the regularization is accepted, it is no more open for the applicants to challenge the cut-off-date.

5. This contention cannot hold water. Since, it was a policy/decision of Cabinet of the State Government to choose the cut-off-date. Nowhere, it is mentioned in the Government Resolutions dated 16.10.2012 and 31.10.2013 about choosing the effective date as of

01.06.2012 as to whether the same was by way of settlement or otherwise.

6. In view of above, the State Government particularly at Mantralaya level should file an additional affidavit describing the reasons for choosing cut-off-date as 01.06.2012 within a period of two months.
