3. The learned C.P.O. files on record the copy of the O.A.283/2018 which was dismissed in *limini* on 2<sup>nd</sup> April, 2018. The same is accepted and taken on record.

4. The learned Counsel for the Applicants submits that the challenge in the said OA was on the different grounds. In the present case, all the present Applicants would be governed by the Police Sub Inspectors Recruitment Rules, 1995 and more particularly, Rule 3(b). The said Rule 3(b) indicates that the appointment to the post of Sub Inspector of Police may not be taken as a promotion but selection.

5. Mr. Dere, the learned Counsel for the Respondents 8 and 9 on instructions submits that the M.A.T. Bench at Aurangabad had an occasion to deal with this issue in O.A.1157/2009 on 30<sup>th</sup> December, 2009 (a copy of which is submitted by him and marked 'X1' for identification) and the issue is decided against the above submissions.

6. In the circumstances, without making any comments on merits and in view of the common submissions from both the parties that the earlier order as detailed supra, is challenged before the Hon'ble High Court and the same is fixed for hearing on 12<sup>th</sup> April, 2018, instead of issuing notice, it will be better to keep the present O.A. for further hearing to 13<sup>th</sup> April, 2018.
