The applicant has challenged the impugned orders dated 14.11.2018 and 20.11.2018 issued by the respondent Nos. 1 and 2 respectively, by which he has been transferred from the post of Sub Divisional Water Conservation Officer, Zilla Parishad Minor Irrigation Sub-Division, Karjat, Dist. Ahmednagar to Sub Divisional Water Conservation Officer, Zilla Parishad Minor Irrigation Sub-Division, Wadasa, Dist. Gadchiroli.

3. Learned Advocate for the applicant has submitted that the applicant has been relieved, but he has not joined his new posting. He has submitted that the impugned orders are in violation of the provisions of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (in short "the Transfer Act 2005"). He has submitted that the applicant is going to retire on superannuation in the

month of July 2019 and therefore, he prayed to grant stay to the operation and execution of the impugned orders dated 14.11.2018 and 20.11.2018.

4. Learned Presenting Officer has submitted that the applicant has been relieved in view of the impugned order dated 20.11.2018 on 06.12.2018, therefore, no question of granting stay to the execution of impugned orders arises. Therefore, she prayed to reject the interim relief as prayed for by the applicant.

5. On perusal of the record, it reveals that the applicant has been transferred from his present posting and in view of the impugned order dated 20.11.2018, he has been relieved from his posting on 06.12.2018. Since the order of transfer has been implemented, no question of granting stay to the impugned order arises. In view of this, in my view, it is not a fit case to grant interim relief. Hence, the interim relief as prayed for by the applicant is rejected.
