2. Learned Presenting Officer, on instructions from Dr. Ulhas Dattatraya Marulkar, Deputy Director (Hospitals), Mumbai, who is the Chairman of Commensurate Expenditure Committee, is present today before this Tribunal, has submitted that the committee has been constituted by the Government to consider the claim of the Government employees regarding reimbursement of medical bills. He has submitted that the claim of the applicant has been rejected by the then committee and the minutes of the meeting has been maintained. He has submitted that the committee consists of medical experts to take decisions regarding amount of medical reimbursement to be paid to the Government employees on the basis of Maharashtra Medical Reimbursement Rules 1961 and G.R. issued by the Government from time to time.

3. Learned Advocate for the applicant has submitted that the then committee has not recorded the reasons while rejecting the claim of the applicant

partially and, therefore, he prayed to quash and set aside the impugned order and sent back the matter to the committee for taking appropriate decision afresh.

4. Learned Presenting Officer has submitted that he has no objection to send back the matter to the concerned committee for considering the same afresh.

5. On perusal of the record, it reveals that the then committee of reimbursement of bill has partly rejected the claim of the applicant regarding surgery charges and medical bill to some extent without recording reasons and without quoting rules. Therefore, considering the said fact, in my view, it is just and proper to send back the matter to the concerned committee to take appropriate decision regarding the claim of the applicant and to decide it within a period of one month from the date of this order as per rules by recording reasons.

6. In view of the submissions made by the learned Advocate for the applicant and learned Presenting Officer, it is just and proper to quash and set aside the impugned order / communication dated 12.09.2017 and relegate the matter to the Commensurate Expenditure Committee for taking appropriate decision afresh.

7. In view of this, the Original Application is allowed. The impugned order/communication dated

12.09.2017 is hereby quashed and set aside. The matter is relegated back to the concerned committee i.e. Commensurate Expenditure Committee for taking appropriate decision afresh within a period of one month from the date of this order and communicate the decision therein to the applicant in writing.

8. The applicant is directed to furnish necessary documents before the concerned Committee before its meeting, which is to be scheduled in this month.

9. Learned Advocate for the applicant has submitted the he will hand-over the papers to the Chairman of the Committee today.

10. Shri Ulhas Dattatraya Marulkar, Deputy Director (Hospitals) Mumbai, has agreed to accept the same and assured to place the same before the committee.

11. There shall be no order as to costs.

2. Learned Advocate for the applicant has submitted that the applicant is not pressing the prayer clause 10(D) and he is pressing prayer clauses 10 (B) and (C) only.

3. Learned Advocate for the applicant has submitted that the applicant was punished in two departmental enquires and his annual three increments commencing from 01.07.2015 have been withheld in one departmental enquiry and in another departmental enquiry, one increment has been withheld for one year. He has submitted that in the first D.E., the applicant has undergone the punishment imposed on him and the punishment imposed in the second D.E. the applicant is undergoing the same and the said punishment will be end in the month of June 2019. The respondents in their affidavit in reply in paragraph no. 3.4 (page No. 55 of paper book of O.A.) have admitted the said fact. He has submitted that in view of the contentions raised by the respondents, the applicant's case may be considered as per the order dated 13.01.2016 after 30.06.2019. He has submitted that the O.A. may be disposed of with a

direction to the respondents to consider the case of the applicant after 30.06.2019.

4. Learned Presenting Officer has submitted that the respondents will consider the case of the applicant for relieving him on promotional post after end of punishment imposed on the applicant i.e. on 30.06.2019 and therefore, she prayed to pass necessary orders.

5. On perusal of the record, it reveals that the punishment imposed on the applicant is still have to be executed and the punishment will come to an end on 30.06.2019 and thereafter, the applicant will be relieved for the promotional post as per the order dated 13.01.2016, if any other enquiry is not pending against him. Therefore, in view of this, it is just and proper to direct the respondents to consider the case of the applicant for relieving him for joining on the promotional post after completion of the punishment imposed by him i.e. after 30.06.2019.

6. In view of this, the O.A. is disposed of with a direction to the respondents to consider the claim of the applicant to relieve him after 30.06.2019 for joining on the promotional post, if the applicant is otherwise eligible or no other enquiry is pending against him. There shall be no order as to costs.
