2. None appeared for the Applicant. The Applicant has prayed to direct the Respondents to grant pension at the rate of Rs.9175/- by filing the present Original Application.

3. By communication dated 16.11.2019, the Respondents has submitted that the pension of the Applicant has been revised and pension at the rate of Rs.9175/- has been given to him and the arrears of the pension for the period from 1.12.2013 to 31.10.2019 has been disbursed to him on 11.11.2019. From the said communication it reveals that the relief claimed by the Applicant is hereby redressed and therefore, nothing survives in the Original Application.
