Respondent no. 2 may file an affidavit clearly bringing out methodology of promotion to M.D.S, Group-B cadre. It appears that till 2014, 7 cadres were eligible to be promoted to M.D.S Group -B. One more cadre is added in 2014. There are four Zilla Parishads in Konkan Division. Whether the seniority lists of these 7/8 cadres from 4 districts are maintained separately for promotion to their respective quotas or are they merged to form a single list. If a single list is prepared, the lists for the year 2003 and thereafter may be placed on record. If a single list is maintained for promotion, how the reservation is applied may also be clarified. This should be done within a period of two weeks from today.
