2. Applicant has challenged the orders dated 04-01-2018 and 06-01-2018 issued by the respondent no.1 and 2, respectively, thereby cancelling his earlier transfer order dated 15-06-2017 transferring him from Ambajogai to Dhule and reposting him at Ambajogai by filing the O.A.

3. Learned Advocate for the applicant has submitted that the applicant has been transferred to Dhule from Ambajogai on the basis of order issued by the respondent no.2 on 15-06-2017 and the respondent no.4 has been transferred on his post at Ambajogai. He has

submitted that the respondent no.4 Chandulal s/o. Barku Sathe had filed O.A.No.385/2017 challenging that order on various ground and in that applicant was arrayed as respondent no.4. He has submitted that during the pendency of the O.A., respondent no.2 has withdrawn and cancelled the order dated 15-07-2017 and accordingly, O.A. has been disposed of.

4. Learned Advocate for the applicant has further submitted that thereafter respondent nos.1 and 2 have issued the impugned orders and reposted the applicant at his original posting i.e. at Ambajogai. He has submitted that two daughters of applicant are mentally retarded and are taking education at Dhule, and therefore, he prayed to stay the execution of the impugned orders. He has submitted that the applicant has not been yet relieved from the present posting at Dhule, therefore, he prayed to grant interim relief in terms of prayer clauses "E" and "F".

5. Learned P.O. has submitted that during the pendency of the earlier O.A.No.385/2017,

respondent no.2 had cancelled the order dated 15-07-2017, and thereafter, O.A. had been disposed of. He has submitted that the present applicant was respondent no.4 in that matter and he has not appeared and contested the O.A.385/2017 though notices were served on him. It is further submitted by the respondents that the present applicant had an opportunity to raise his grievance but he failed to avail that opportunity. Learned P.O. has submitted that since the impugned orders have been issued in view of the O.A.No.385/2017 filed by the respondent no.4, the applicant is not entitled to claim interim relief. Therefore, the learned P.O. prayed to reject the interim relief.

6. I have gone through the documents placed on record by the parties. By order dated 15-07-2017, respondent no.2 had transferred the applicant at Dhule from Ambajogai and transferred the respondent no.4 to Ambajogai from Dhule. Being aggrieved by the said transfer order, respondent no.4 Chandulal Sathe had filed O.A.No.385/2017. During the course of hearing

of that O.A. the respondent no.2 had cancelled the transfer order dated 15-07-2017, and therefore, O.A. came to be disposed of. Thereafter, the impugned orders have been issued by the respondent nos.1 and 2 accordingly. In that proceedings the applicant was a party as respondent no.4. He was served but did not appear and contest the matter. Earlier transfer order dated 15-07-2017 was made by the respondent no.2 on the request of the applicant and the transfer of the respondent no.4 was made on administrative ground. But the order dated 15-07-2017 had been cancelled by respondent no.2 and in consequence of it the impugned orders have been issued.

7. In these circumstances, in my opinion, prima facie, the impugned orders are issued in view of the O.A. filed by the respondent no.4. Prima facie, I find no illegality in the impugned orders. The applicant has not made out a case to grant interim relief as prayed for. Therefore, prayer for interim reliefs is rejected.

8. Issue notices to the respondents, returnable on 26-02-2018.

9. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

10. Applicant is authorized and directed to serve on respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

11. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

12. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date.

Applicant is directed to file affidavit of compliance and notice.
