The oral request of Mr. Bandiwadekar, the learned Advocate to correct the mis-description of the post in prayer clause (b) is allowed and the words, "Assistant Commissioner of Sales Tax" be substituted by the words, "Assistant Conservator of Forest". The amendment be effected forthwith in the main copy as well as in the copy of the learned C.P.O. as well.

Heard the rival submissions. I express no final opinion with regard to the issue of limitation which by far is the main stay of the learned C.P.O's submission today. I, however, make it clear that as of now, I do not think I can conclusively and finally hold this OA to be barred by limitation *inter-alia* because it is a matter of promotion and the Tribunal will be to find out the nexus, if any, between the five dates mentioned in the relevant prayer clause. Having said that, as far as the interim relief is concerned, I am of the opinion that the liberty is reserved for the Applicant to renew the same request on the next occasion and the next date will be appointed taking into consideration the concerns of both the sides. The Respondents must take care to file Affidavit-in-reply at least for the purposes of the interim relief and in that, they may also deal with the fact as to whether other than the departmental enquiry referred to herein, there is any other reason for not promoting the Applicant.
