Learned Advocate for the applicant has produced a copy of the communication dated 05.04.2018 received from the office of the S.P., Solapur (Rural) along with the copy of the representations made by the applicants. Same are taken on record. Learned Advocate has also produced a copy of the order passed by the Hon'ble Chairman on 18.01.2018 in O.A. No. 1042/2016. He has submitted that the SP, Solapur has not taken the decision on the representations made by the applicants considering the judgment/order passed by this Tribunal in O.A.1042/2016, he has submitted that the applicant in that O.A. is also serving on the establishment of the respondent no.3 and, therefore, it is just to direct the respondent no.3 to take the decision on the representation/application made by the applicants on the ground of parity.

3. Learned P.O. for the respondents states that she has no instructions from the respondent no.3. She prays for time to take instructions in this regard.

4. On going through the order passed in OA 1042/2016, it reveals that the facts and issues involved in that case is similar to the facts and issues involved in this case. The applicant in OA No.1042/2016 is also serving on the establishment of respondent no.3. This Tribunal has extended the benefit to the applicant in that case on the basis of the judgment of Supreme Court as well as High Court.

5. In these circumstances, it is just to direct the respondent no.3 to take the decision on the representation /application made by the applicants within two weeks considering the order passed by this Tribunal in O.A.No.1042/2016. If the respondent no.3 has any legal impediment to extend the benefits to the applicants then the respondent no.3 may file short affidavit stating the reasons for not extending the benefits to the applicants.
