In O.A.No.519/2019, the Applicant has challenged the transfer order dated 31.05.2019.</p> <p data-bbox="743 1424 1516 1676">3. By order dated 10.06.2019, interim stay has been granted on the submission that the Applicant is due to retire within next three months. Thereafter, M.A.No.346/2019 is filed by Private Respondent to vacate the interim stay on the ground that the Applicant has suppressed the material fact.</p> <p data-bbox="743 1701 1516 1895">Likewise, the Government has also filed M.A.No.350/2019 to vacate the interim stay on the ground that the Applicant has suppressed the material fact and he is not in fact due to retire within next three months.</p>

3. During the course of hearing, it was transpired that the Applicant had already made several representations to extend him the benefit of extension of two years service in terms of G.R. dated 29.08.2018. However, he has suppressed this material fact in O.A.

4. Interim relief was granted on the pleading that he was due to retire in next three months. Thus, it is apparent that the Applicant has suppressed the material fact and obtained interim relief by suppression of material fact. Therefore, interim relief deserves to be vacated.

6. In fact, where such aspect of suppression of material fact surfaces on record, such application deserves to be dismissed in limine with heavy cost.

7. However, Shri A. V. Bandiwadekar, learned Counsel for the Applicant submitted that his client does not want to proceed with the O.A. and sought permission to withdraw the O.A. itself.

8. In view of above, without going further the matter is disposed of.

9. Allowed to withdraw the O.A.No.519/2019. Interim stay granted by this Tribunal stands vacated.

10. Accordingly, both the Misc. Applications are disposed of.

11. Before parting with the matter, the Tribunal hope that suppression of material fact should not occur in future and pleadings should be fair enough otherwise such Original Applications will be dealt with sternly.
