2. The applicant has filed the present Original Application and sought direction to the respondents to correct his date of birth recorded in the service record as "01.07.1964" instead of "01.07.1961". The office has raised objection that the applicant has not approached this Tribunal within stipulated time and therefore, the present O.A. is barred by limitation.

3. Learned Advocate for the applicant has submitted that the applicant was appointed by the order dated 31.08.1991 w.e.f. 11.06.1991. He has submitted that the date of birth of the applicant has been wrongly recorded in the service record as "01.07.1961" instead of "01.07.1964". Therefore, the applicant had filed application dated 16.10.1991 for correction of date of birth recorded in the service record as "01.07.1964" instead of "01.07.1961". He has submitted that the concerned authorities have not decided his application within reasonable time. But the applicant was under impression that his date of

birth was corrected. He has submitted that the applicant came to know about the date of birth recorded in the service record only when he received letter from the respondents dated 15.11.2018. As the respondents have not taken decision on his application, he approached this Tribunal and sought direction against the respondents. In view of these facts, the present O.A. is well within limitation.

4. Learned Presenting Officer has submitted that the applicant ought to have approached this Tribunal within one year after expiry of period of six months from the date of filing of the application dated 16.10.1991, if there was any inaction on the part of the respondents. But the applicant has not approached this Tribunal within stipulated time. He has submitted that the present O.A. is hopelessly barred by limitation.

5. On perusal of the record, it reveals that the applicant was appointed w.e.f. 11.06.1991 as Police Sub Inspector. Thereafter his service record has been prepared and his date of birth has been recorded as 01.07.1961 in the service record, on the basis of the certificate produced by him. The record shows that on 16.10.1991, the applicant approached the respondents for changing entry regarding his date of birth by filing an application. The respondents by the letter dated 29.10.1991 directed the applicant to produce legible copies of the documents. There is nothing on record to show as to whether the applicant had complied with

the direction given by the respondents and produced the documents regarding his date of birth. There is nothing on record to show whether the respondents have decided the said application.

6. Even if it is assumed that the respondents have not taken any decision on the application dated 16.10.1991 filed by the applicant as per the provisions of Section 21 of the Administrative Tribunals Act 1985, the applicant has to file the O.A within one year after expiry of period of six months from the date of application. The applicant ought to have filed the O.A. on or before 16.04.1993, but the applicant has not filed the O.A. within stipulated time. The applicant has filed O.A. after laps of 26 years. The O.A. is not filed within limitation as prescribed in Section 20 of the Administrative Tribunals Act, 1985. The present O.A. is hopelessly barred by limitation. Hence, the O.A. deserves to be rejected.

7. In view thereof, the O.A. stands rejected as barred by limitation with no order as to costs.

2. The applicant has challenged the impugned order dated 27.02.2008 passed in the Departmental Enquiry and the order dated 07.10.2009 passed in the appeal preferred by him confirming the order dated 27.02.2008. By the said order, the applicant was held guilty of the charges leveled against him and he was punished. According to the applicant, the delay of 2669 days has been caused for filing the present O.A. It is his contention that because of several Departmental Enquires and Criminal Cases pending against him, he could not be able to file the O.A. in time and therefore, he approached this Tribunal by filing the present M.A. and prayed to condone the delay caused in filing the accompanying O.A.

3. Learned Presenting Officer has submitted that the inordinate delay of more than 10 years has been caused for filing the accompanying O.A. and therefore, she prayed to reject the M.A.

4. On perusal of the record, it reveals that the impugned order has been passed on 27.02.2008 in the D.E.. The applicant has challenged the said order in the appeal, which was decided on 07.10.2009. The applicant ought to have filed the O.A. on or before 07.10.2010 in view of the provisions of Section 21 of the Administrative Tribunals Act 1985. The delay of more than 8 years and six months has been caused for filing the accompanying O.A. The reasons mentioned by the applicant for filing the O.A. within stipulated time are not justifiable. There is no just ground to condone the inordinate delay caused for filing the accompanying O.A. Hence, the M.A. deserves to be rejected.

5. In view of this, the M.A. stands rejected. Consequently, O.A. stands rejected as barred by limitation. There shall be no order as to costs.
