2. By filing the present Original Application, the applicant has prayed to direct the respondents to pay pensionary benefits admissible to him.

3. The respondent Nos. 1 to 6 have filed their affidavit in reply and contended that all pensionary benefits have been extended to the applicant, but the benefits in respect of compulsory leave period and suspension period had not been extended to the applicant. It is their contention that the Departmental Enquiry has been initiated against the applicant and now the applicant has been exonerated from the charges levelled against him and the proposal regarding compulsory leave period and suspension period has been forwarded to the respondent No. 1. But the respondent No. 1 has not yet decided the same. They have contended that after decision on the proposal by the respondent No. 1, all the benefits will be extended to the applicant. They have also contended that the G.P.F. amount and provisional pension had been paid to the applicant and the

remaining amount due to the applicant will be paid in due course. They have mentioned the details regarding the amount due to the applicant and the action taken by the department in paragraph No. 11 of their affidavit in reply, which is at page No. 80.

4. Learned Advocate for the applicant has submitted that the applicant has not received pensionary benefits except provisional pension and G.P.F. He has submitted that he has been exonerated from the charges levelled against him in the D.E. The proposal to extend the remaining benefits to him has been forwarded by the respondents, but it is not yet decided by the respondent No. 1. Therefore, he prayed to direct the respondent No. 1 to take decision on the proposal at the earliest and to dispose of the O.A.

5. Learned Presenting Officer has submitted that the reasonable time may be given to the respondent No. 1 to take decision on the proposal to extend the benefits due to the applicant. He prayed to pass necessary orders.

6. The applicant is exonerated from the charges levelled against him in the D.E. in view of the order dated 3.10.2018 and thereafter, proposal to extend the pensionary benefits to the applicant has been forwarded by the respondent No. 2 to the respondent No. 1. This fact is evident from paragraph No. 15 of the affidavit in reply filed by the respondent Nos. 1 to 6. The respondent No. 1 has not yet decided the

said proposal. Therefore, it is just and proper to direct the respondent No. 1 to take decision on the proposal forwarded by the respondent no. 2 regarding the benefits of compulsory leave period and suspension period within a period of three months from today.

7. Accordingly, the O.A. is disposed of with a direction to the respondent No. 1 to take appropriate decision on the proposal forwarded by the respondent No. 2 regarding compulsory leave period and suspension period of the applicant within a period of three months from the date of this order and communicate the decision therein to the applicant in writing. There shall be no order as to costs.
