2. Learned Advocate for the Applicant has submitted that the Applicant has been suspended by the Respondent No.2 and thereafter the Respondent No.1 issued impugned order directing the applicant to hand over the charge of the post of Applicant to the Respondent No.5. He has submitted that inspite of said order the Applicant is holding the charge of the said post and he is not yet relieved from the post and therefore, he prayed to direct the Respondents to maintain status-quo so far as the charge of his post is concerned.

3. Learned P.O. for the Respondents has submitted that the Applicant has been suspended w.e.f. 03.04.2019 and thereafter the Respondent No.1 ordered to hand over the charge of the post of the Applicant to the Respondent No.5 i.e. Shri S.V. Bhairat, Conservation Officer, Sub-Division, Parbhani but the Respondent No.5 has not taken the charge of the post. The Respondent No.1 issued another order

dated 06.06.2019 and directed Shri K.B. Jejurkar, Water Conservation Officer to take the charge of the post of the Applicant. He has submitted that Shri K.B. Jejurkar took charge of the post of the Applicant on 06.06.2019 and now he is discharging the duties since then. Therefore, he has prayed to reject prayer of the Applicant for interim relief.

4. On perusal of record it reveals that the applicant was suspended by the order dated 03.04.2019. Shri K.B. Jejurkar took the charge of the post of the Applicant on 06.06.2019 and he is discharging the duties. Therefore, I do not find any substance in the submission advanced by the learned Advocate for the Applicant that the applicant is still holding the charge of the post. Shri K.B. Jejurkar is holding additional charge of the said post and the Applicant has been relieved from the post. Therefore, no question of granting status-quo as claimed arises. Hence, the request of the Applicant to grant of interim relief is rejected.

5. Issue notices to the respondents, returnable on 17.07.2019.

6. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

7. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper

book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

8. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

9. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

10. If notice is not collected within 7 days or proof of service is not produced before 3 days of the next date, case shall automatically stand dismissed without further reference to the Tribunal.
