Interim relief is granted as per prayer clause 13 (G) and the same is as follows:-

Therefore, it is hereby directed that the copy of the present order shall be sent to the Principal Secretary and Additional Chief Secretary, G.A.D., who shall take into consideration this difficulty and grant of interim relief in various cases as well pendency of many cases on the same issue. Thereupon, both the Secretaries shall work out amendments to the concerned rules as may be deemed fit to overcome the above difficulty and file report on or before next date.
