3. Learned Presenting Officer has submitted that the reasonable time may be given to the respondent No. 3 to decide the representation dated 26.08.2015 and accordingly, the O.A. may be disposed of.

4. In view of the submissions advanced by the learned Advocate for the applicant, the O.A. is disposed of with a direction to the respondent No. 3 to

decide the representation dated 26.08.2015 filed by the applicant on merit as per rules within a period of four months from the date of this order and communicate the decision therein to the applicant in writing. There shall be no order as to costs.

In view of this, it is just and proper to direct the respondent No. 3 to complete the said process within a period of two months from the date of this order.

In view of this, the O.A. stands disposed of with a direction to the respondent No. 3 to consider the candidature of other candidates other than the respondent No. 4, who appeared for oral interview as per the rules and appoint the eligible candidate on the post of Police Patil of village Bhandegaon, Tq. 4. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

5. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
