2. The applicant has moved the application for restoration of the O.A.No.328/2018 which was dismissed for non-compliance of the order.

3. Learned Advocate for the applicant has submitted that due to mistake on the part of the Advocate notice issued in O.A.No.328/2018 had not been collected in the stipulated time. Therefore, O.A. stood dismissed for non-compliance.

4. Learned P.O. has submitted that earlier also O.A. was dismissed for non-compliance of the order. Thereafter the applicant had filed

M.A.No.248/2018 for restoration of the O.A. It was allowed by order dated 27-06-2018 and O.A. was restored. But again the O.A. came to be dismissed as the applicant had not collected the notices. He has submitted that the applicant was not diligent in conducting the matter. Learned P.O. has therefore prayed not to restore the O.A. and to dismiss the M.A.No.286/18 for restoration.

5. On perusal of the record it reveals that the applicant has filed the O.A. challenging appointment of respondent no.5. Notices were issued to the respondents by order passed by this Tribunal on 31-05-2018. The applicant had not collected the notice and also had not filed service affidavit in stipulated time and the O.A. was dismissed for non-compliance. Thereafter, the applicant moved M.A.No.248/18 for restoration of the O.A. Considering the reasons put forth in the M.A., the O.A. was restored and fresh notices were issued in the O.A. but the applicant had not collected the notices in time.

Consequently, O.A. again came to be dismissed for non-compliance.

6. It is contention of the applicant that the Advocate could not able to collect notice in time due to some difficulty. It seems that inspite of opportunity given to the applicant, applicant has not availed the same. Applicant is not diligent in conducting the matter, and therefore, the O.A. was dismissed.

7. Reasons mentioned in the M.A.No.286/18 are not sufficient to recall/set aside the order of dismissal and restoration of the O.A. However, in the interest of justice M.A. can be allowed subject to payment of costs of Rs.5000/- (Rs. Five thousand only).

8. In view of the abovesaid facts, M.A.No.286/18 is allowed subject to payment of costs of Rs.5000/-. Applicant shall deposit the costs on or before 28-08-2018.

9. On depositing the costs order of dismissal passed in the O.A. will be recalled and O.A. will be restored to its original position.
