ORDER

1. Shri V.U. Sherkhane, the learned Advocate for the Applicant and Ms. S. Suryawanshi, the learned Presenting Officer for the Respondents.

2. Today, during hearing it has transpired that the matter as to whether candidate for appointment as Police Constable against whom a criminal case is/was registered should be appointed is to be decided by the committee headed by Collector and the committee has to send the report of its decision to the Government for its decision.

3. We were informed by the learned P.O. for the Respondents that in present case, the matter was referred to the Collector in April, 2017. Normally decision in the matter of employment should not be delayed.



4. We therefore direct the committee under the aegis of Collector to take decision expeditiously in any case before the next date and send its report to the Government and furnish copy of report before this Tribunal on 23.06.2017.

5. During hearing it has also transpired that the Government Resolution by virtue of which the committee under aegis of Collector is appointed and procedure to take decision is laid down, does not refer to Rule 5 of Police Constable Recruitment Rules, 2000. Various Government Resolutions cited before us do not refer to constitution of any such committee under Rule 5 supra. Officers who have been attending this case seem to be totally oblivious to the said rule i.e. Rule 5 of Police Constable Recruitment Rules, 2000.

6. We direct the Government to compile information as to whether any committee as contemplated by Rule 5 of Police Constable Recruitment Rule, 2000 titled as high power committee or otherwise is constituted, and furnish documents/orders in that regard.

7. Therefore it is necessary to seek information and secure clarification thereof from the Principal Secretary, Home Government of Maharashtra.

8. We therefore direct the Principal Secretary to file his own affidavit on following points:-


- (a) As to whether High Power Committee is constituted for taking decision furtherance to Rule 5 of Police Constable Recruitment Rule, 2000.
- (b) What is standard procedure to be adopted by the committee whatsoever for purpose and object thereof.

9. Affidavit be filed on or before 22.06.2017.

ORDER

1. Heard Shri K.R. Jagdale, the learned Advocate for the Applicant and Smt. Archana B.K., the learned Presenting Officer for the Respondents.
2. Smt. Archana B.K., the learned Presenting Officer for the Respondents states that time may be granted for filing affidavit-in-reply.
3. Record shows that this Tribunal has passed a detailed speaking order on 05.05.2017, and also issued notice.
4. On enquiry, learned P.O. states that order was communicated by letter dated 5/6.05.2017 through e-mail at 4.43 p.m. on 06.05.2017. However, response is still awaited.
