The applicant has filed the Original Application St. No. 1148/2019 seeking declaration that he is entitled to be appointed w.e.f. 01.08.2004 on the vacant post of his father as Sweeper and also entitled to get all service benefits w.e.f. 01.08.2004. As there was delay of more than 13 years 9 months and 20 days for filing the accompanying O.A., he has filed the present M.A. No. 320/2019 for condonation of delay.

3. It is contention of the applicant that he has been appointed on 13.08.2012 on the post of Sweeper with the respondents. It is his further contention that his father has retired in the year 2004 while working on the post of Sweeper and therefore, he sought appointment on the vacant post of his father, but the respondents had not given him appointment initially and after persuading the matter, they have appointed him on the post of Sweeper w.e.f. 2012. Therefore, he is entitled to get appointment on the post of Sweeper w.e.f. 01.08.2004.

4. There is inordinate delay of more than 13 years for filing the Original Application. No justifiable cause has been shown by the applicant for condonation of delay. In the absence just cause, the inordinate delay cannot be condoned. Hence, the M.A. No. 320/2019 stands rejected.

5. On perusal of the record, it reveals that the applicant was not in the Government service in the year 2004 and he has been appointed as Sweeper first time on 13.08.2012. Therefore, no question of giving deemed date of appointment from 01.08.2004 as claimed by the applicant arises. There is no merit in O.A. Hence, it deserves to be dismissed.

6. In view of the above, the M.A. and O.A. stand rejected with no order as to costs.
