2. O.A. no. 246/2019 has been filed by the applicants for the following interim reliefs :-

“(C) Pending the hearing and final disposal of this Original Application, the respondent no. 2 may kindly be directed to issue an orders in favour of the applicants thereby appointing them as Law Instructors with the Police Training Centre, Babhalgaon, Tal & Dist. Latur, forthwith.

“(D) Pending the hearing and final disposal of this Original Application, the respondent no. 2 may kindly be directed to make an arrangement to accommodate the applicants on the posts of Law Instructors with the Police Training Centre, Babhalgaon, Tal. & District Latur on clock hour basis and for that purpose issue necessary orders.”

3. The Tribunal granted interim relief as per prayer clause (C) of the original application without going into the merit of the matter vide order dtd. 11.3.2019.

4. The respondents in the original applicant have now filed Misc. Application no. 156/2019 for vacating the interim relief granted by the Tribunal in favour of the applicants vide order dtd. 11.3.2019.

5. In the O.A. no. 246/2019 the following submissions were made by the applicants :-

(A) Applicant nos. 1 & 2 have worked for eleven years from 2007 and Applicant nos. 3 & 4 have worked for four years with the respondents.

(B) The claims of the present applicants were not considered. Except the present Applications all other Law Instructions were continued, the names of the applicants were not considered and enlisted in the list of Law Instructors published by the Respondent no. 2.

(C) The persons / candidates selected are junior and have less experience.

(D) All the Law Officers working have given representation that they may be given relaxation from appearing in the interview.

(E) It is well settled law that one ad-hoc employee cannot be replaced by another ad-hoc employee.

6. The brief submissions of the applicants in the misc. application / respondents in the O.A. are as follows :-

(A) The applicants were appointed as Law Instructions as per the G.R. dtd. 15.9.2006 for the period of 11 months on contractual basis, which was renewable for another two terms.

(B) The respondents issued fresh advertisement on 17.11.2017 in response of which total 266 applications were received. A total of 155 candidates appeared in the interview.

(C) The applicants appeared in the interview but they have failed in the interview.

7. In fact the applicants have not brought out the correct facts before the Tribunal in Original Application that they were not considered in the interview.

8. In reply to the misc. application the applicants in the O.A. have now admitted that they were considered and deliberately given less marks so that their services can be discontinued.

9. In reply to the misc. application the applicants in the O.A. have submitted that there are 12 sanctioned posts at Babhalgaon Police Training Centre, Tal. & District Latur and out of 10 selected candidates one

candidate has not joined. Therefore as on today there are total of three vacant posts of Law Instructors. In reply to misc. application the applicants in O.A. submitted that the applicant no. 1 is at sr. no. 55 and applicant no. 2 is at sr. no. 64.

10. In view of above discussion, the interim relief granted by the Tribunal vide order dtd. 11.3.2019 in O.A. is hereby vacated. The respondents are liberty filled up three vacant posts as per merit.

11. Accordingly, the Misc. Application no. 156/2019 is hereby allowed and disposed of without any order as to costs.
