

The Applicant has challenged the order dated 05.03.2020 whereby her services were diverted to the office of Tahasildar, Purandar, District Pune on the post of Awal Karkun. She was serving on the post of Circle Officer, Kumbhalvalan, Tal.: Purandar, District Pune. The Applicant has challenged the order dated 05.03.2020 contending that it amounts to mid-term and mid-tenure transfer in contravention of 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005.</p> <p>3. The matter was taken up for admission on 12.03.2020 and was adjourned for today to facilitate learned P.O. to take instructions from the Respondents as to whether the impugned order is a temporary arrangement for a particular period.</p> <p>4. Today, the learned P.O. on instruction submits that the order dated 05.03.2020 is temporary arrangement whereby the services of the Applicant were diverted to the office of Tahasil Office, Purandar, District Pune on the post of Awal Karkun. He further submits that it is deputation for specific period upto 31.05.2020 and thereafter, the Applicant will be reposted on her original post.</p> <p>5. As such, in view of the statement made by the learned P.O, the impugned order dated 05.03.2020 being purely deputation upto 31.05.2020, the O.A. deserves to be disposed of.</p> <p>6. O.A. is disposed of with direction that the Applicant be reinstated on her original post after the expiration of period of deputation (which would be ending on 31<sup>st</sup> May, 2020.)</p>

7. The Respondents are at liberty to curtail the period of deputation and may pass appropriate order even before 31<sup>st</sup> May, 2020, if deem fit.
