submitted that the file produced by him is not an original file and the original file and original record is with the office of the Director of Education, Pune and file produced by him is an office copy/file maintained by the Deputy Director of Education, Aurangabad. On perusal of the said file, it reveals that this is an original file regarding the transfers of the employees as there it contains original proposal and other original documents.

Therefore, the respondents are directed to file short affidavit in that regard and also directed to produce original record and file regarding the transfers of the employees maintained by the Director of Education, Pune office. They are also called upon to show cause as to why appropriate action should not be initiated against him for fabrication of the record and documents and its production before this Tribunal.
