5. On perusal of documents on record, it reveals that the applicant's father Dhulaji Dhondiram Shriram died on 14-06-1998. At the time of death of his father, the applicant was 12 years old. Date of birth of the applicant is 26-01-1986 and he attained age of majority on 26-01-2004. After attaining age of majority, he filed application dated 02-07-2008 before the respondents claiming appointment on compassionate ground. Said application came to be rejected on 13-07-2008 on the ground that it has not been filed within limitation. The applicant has not challenged the earlier order 13-07-2008 and thereafter filed another application before the respondents which has been rejected by the impugned order dated 01-09-2019.

6. No justifiable reason has been shown by the applicant for condoning the delay caused for filing the O.A. Delay is of more than 12 years for filing the O.A. from the date of rejection of his earlier application dated 02-07-2008. The delay is deliberate and intentional. In the absence of sufficient and just cause delay cannot be condoned. Not only this but on merit

also there is no substance in the case. Hence, the M.A. deserves to be rejected.
