Now the question of fate of applicant which goes to the eligibility of the applicant depends on the fact as to whether the applicant was suffering from the deficiency in eye sight described as 'Amblyopia of Right Eye' before joining employment or that deficiency has occurred after joining the employment.

10. In the aforesaid background issue notice with a specific direction to the respondent no.2 to state on affidavit on due date as to what procedure is to be adopted for securing expert opinion on the foregoing question:

Whether Amblyopia of Right Eye of the applicant existed prior to his ¹ date of joining in the employment of service of Police?
