1. Heard Smt. K. Patil, learned Advocate for the Applicant, Smt. K.S. Gaikwad, learned Presenting Officer along with Shri M.D. Lonkar, learned Advocate for the Respondents.
2. Shri M.D. Lonkar, learned Advocate states that he has been appointed as Special Counsel by the Respondents in this O.A..
3. Smt. K. Patil, learned Advocate for the Applicant made a submission that earlier also applicant had filed another O.A.No.1108 of 2013, seeking extension in the retirement age, which was made available to the teachers working in non-agricultural University.
4. By order dated 29.09.2015 in the aforesaid O.A. it was directed that the Librarians in medical colleges should be treated at par by the Librarians in non-medical colleges for the purpose of age of retirement on superannuation by judgment dated 20.06.2015. Learned Advocate Smt. Patil stated that though the Applicant has been continued to work as Librarian she is not yet paid salary from December, 2015.

5. Learned Advocate Smt. Patil further states that Applicant is being pressurized to concede her case regarding retirement age which is before the Hon'ble High Court by way of challenge in the Writ Petition filed by the State challenging the decision of this Tribunal, if she wants to get the benefit to new pay scale authorized by the University Grants Commission to the Librarians working in non-agricultural Colleges and Universities.

6. Learned Advocate Shri Lonkar stated that the Government by letter dated 14.07.2017 has sought information from the Director, Medical Education and Research in this regard. This report is expected within a period of two weeks and thereafter decision will be taken by the Government. Government will file the affidavit as sought by this Tribunal within a period of four weeks.

7. Respondents are directed to release Salary of the Applicant as per old pay scale without losing any further time. Adjourned after four weeks.

8. Hamdast and Steno copy is allowed to both the parties.
