Heard Shri Ajay Deshpande, learned Advocate for the applicant and Shri M.P. Gude, learned Presenting Officer for respondent Nos. 1 to 3. Shri S.R. Yadav (Lonikar), learned Advocate for respondent No. 4 and Shri S.S. Deshmukh, learned Advocate for respondent No. 5, are absent.

2. Learned Advocate for the applicant has submitted that the date of birth of the applicant has been wrongly recorded in the service recorded as "14.11.1959" instead of "14.01.1962". He has submitted that the applicant was initially appointed on the establishment of respondent No. 4 on 26.12.1989, but thereafter on promotion he was transferred on the establishment of respondent No. 1 in the State Cadre on 05.08.2015. He has submitted that the applicant has filed an application for correction of date of birth recorded in the service record on 01.02.1991 and produced necessary documents along with the said application. The applicant has also made representation to the respondent Nos. 1 and 2 on 04.02.2016 (Annexure A-10). The said application was made by the applicant within stipulated time, but the respondent No. 4 had not decided the same. He has

submitted that thereafter he persuaded the matter before the respondent Nos. 1 and 2, but they have not taken decision on it. Meanwhile, the applicant retired on attaining the age of superannuation on 30.11.2017. He has submitted that the representations dated 01.02.1991 and 04.02.2016 filed by the applicant are pending with the respondents and therefore, he prayed to direct the respondents to take appropriate decision on the representations in view of the contentions of the respondent No. 4 raised in his affidavit in reply.

3. Learned Presenting Officer has submitted that the applicant was initially appointed with the respondent No. 4 i.e. Zilla Parishad, Parbhani and the Zilla Parishad, Parbhani is the competent authority to take decision on the representations made by the applicant and therefore, the directions may be issued to the respondent No. 4 in that regard.

4. On perusal of the record, it reveals that the applicant joined the service in the year 1989. At the time of entering the service, his date of birth has been recorded as 14.11.1959 in the service record. On 01.02.1991 (Annexure A-9), the applicant has moved an application with the respondent No. 4 for correction of date of birth as 14.01.1962 and produced the documents along with the said application. But the respondent No. 4 had not decided the said representation on one and other grounds. Thereafter, the applicant came to be promoted and he entered in the State Cadre w.e.f. 05.08.2015. He retired on

superannuation from the State Cadre on 30.11.2017. At the time of retirement of the applicant, the respondent Nos. 1 and 2 were the competent authority to take decision regarding correction of date of birth recorded in his service record. Therefore, in my view, it is just and proper to direct the respondent Nos. 1 and 2 to take appropriate decision on the applications filed by the applicant on 01.02.1991 and 04.02.2016 as per the rules.

5. In view of this, the Original Application is disposed of with a direction to the respondent Nos. 1 and 2 to take appropriate decision on the applications filed by the applicant on 01.02.1991 and 04.02.2016 on merit, as per the rules.

6. The respondent Nos. 1 and 2 are further directed to call for the original papers i.e. application dated 01.02.1991 along with documents produced by the applicant before the respondent No. 4 and other relevant record from the respondent No. 4 before taking the decision. The respondent Nos. 1 and 2 are directed to complete the said exercise within a period of four months from the date of this order and communicate the decision to the applicant in writing.

7. There shall be no order as to costs.

2. Learned Advocate for the applicant has submitted that the applicant is suffering from physical disability and he requested the respondents to place him at the place of his convenience by furnishing necessary preferences. She has submitted that the respondents had not considered the provisions of G.R. dated 09.04.2018 and the Circular dated 15.12.2004 while making the transfer of the applicant. She has submitted that the impugned order has been received to the applicant on whatsapp group on 12.06.2019 and the applicant was on Casual Leave on 13.06.2019, but the respondents had illegally relieved him in contraventions of the provisions of Rule 29 and Rule 31 of the Maharashtra Civil Services (General Conditions of Service) Rules, 1981. She has submitted that the impugned order is illegal and therefore, she has prayed to grant interim relief. In support of her submissions, she has placed reliance on the judgment delivered by the Hon'ble High Court of Judicature at Bombay, Nagpur Bench in **W.P. No. 1439/1999** in

case of **the State of Maharashtra Vs. Smt. Sanjivani Shripad Ranade** decided on **11.09.2014** and the order of this Tribunal passed on 08.03.2019 in **O.A. No. 207/2019** in case of **Shri Brijesh Premal Patil Vs. The State of Maharashtra and Ors.** She has submitted that considering the facts and circumstances of the case, it is just to grant interim relief to the applicant.

3. Learned Presenting Officer has submitted that the applicant has completed his normal tenure of posting at Amalner. He was due for transfer and therefore, preferences/options have been called from him. For general transfers, the applicant has given places of his choice. She has submitted that considering the choices submitted by the applicant and as per administrative convenience, the applicant has been posted at Dhule, which is at the distance of 30 kms. from Amalner by hook or crook. She has submitted that the applicant is intending to work at Amalner. She has submitted that the applicant has been relieved and therefore, there is no just ground to grant interim relief in favour of the applicant. Therefore, she has prayed to reject the interim relief as prayed by the applicant.

4. On perusal of the record, it reveals that the applicant is serving at Amalner since the year 2015. He has completed his normal tenure of posting and therefore, he has been transferred by the impugned order. On perusal of the documents on record, it

reveals that the applicant had given preferences regarding places where to be transferred at the time of general transfers. He had given his options for Amalner and Dhule. The respondents have transferred the applicant at Dhule, which is one of the places of preferences given by the applicant. Therefore, prima-facie it seems that the respondents have taken care of the convenience of the applicant. As submitted by the learned Presenting Officer, the distance between Dhule and Amalner is 30 kms. and therefore, I found that no inconvenience will be caused to the applicant due to the impugned transfer order. Moreover, considering the physical disability of the applicant, the applicant has been given posting in the office of Building Project Sub Division, Dhule. Not only this, but the applicant has been relieved from the present posting on 13.06.2019.

5. In these circumstances, in my view, there is no just ground to grant interim relief as claimed by the applicant. Hence, the request of the applicant to grant interim relief is rejected.

6. Issue notices to the respondents, returnable on 25.07.2019.

7. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

8. Applicants are authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

9. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

10. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicants are directed to file affidavit of compliance and notice.
