

The issue which gives rise to this order is not exactly judicial.

The Applicant having already retired ^{has} as impugned in this OA, an order withholding his pension permanently to the extent of 25%. Even before the arguments could be opened, the learned CPO raised an issue that this is a Division Bench matter so to say. He pointed out that the proceeding under Rule 27 of the Maharashtra Civil Services (Pension) Rules, 1982 would arise only if it was a case of grave misconduct which would be major punishment and Item No.10 of the distribution of work would make it a subject matter to be urged before the Division Bench. In that connection, the learned CPO referred me to Rules 5 and 8 of the Maharashtra Civil Services (D & A) Rules, 1979 also.

Mr. A.V. Bandiwadekar invited my attention to the fact that in the subject of Single Bench Item No.25 is reduction in pension and this reduction could be for any reason whatsoever, although generally and by and large, the said reduction could only be as a result of the culmination of the proceedings under Rule 27 of the Pension Rules.

Apart from the fact that the Item No.25 above referred to clearly provides that it is an incidence of reduction in pension and hence subject of Single Bench in Shri Acharya Ratna Deshbhushan Shikshan Prasarak Mandal, Kolhapur Vs. Bhujgonda B. Patil : 2003 (3) MLJ 602, the Hon'ble Bombay High Court has been pleased to hold that, after retirement, there cannot be any question of any disciplinary proceedings and the proceedings under Rule 27 can be only for the purpose of deciding the issue of pension which will have no link with disciplinary proceedings. That being the state of affairs, in my opinion, the final order made in the proceedings whereagainst this OA arises, would not be a disciplinary proceedings and it would not be an instance of punishment. 25% deduction ultimately would fall within, "affecting the pension". In my opinion, it is a Single Bench matter, but since the learned CPO has requested that the matter be placed before the Hon'ble Chairman for orders on 24th April, 2017.


