The applicant has challenged the impugned order dated 11-09-2019 by which he has been suspended by the respondents in view of the provisions of Maharashtra Civil Services (Discipline & Appeal) Rules, 1979. Rule 17 of the MCS (D & A) Rules, 1979 provides for preferring the appeal against the order of suspension passed under Rule 4 of the Rules, while Rule 18 provides appellate authority to entertain such appeals. Not only this but Rule 4(5) of the Rules provides that the suspension can be modified or revoked by the same authority on representation.

3. Alternate remedy has been provided in the service rules for challenging the suspension order.

The applicant has not availed the said remedy available to him.

4. The present O.A. cannot be entertained/admitted in view of S.20 of the Administrative Tribunals Act, 1985 as the alternate remedy available to the applicant has not been exhausted. The present O.A. is not maintainable. Hence, it stands rejected. There shall be no order as to costs.
