He has submitted that in spite of it the respondent no. 4 the M.P.S.C. is going to conduct the physical test from 20.3.2020 onwards. He has submitted that the applicants and other candidates made representation to the respondent no. 4 the M.P.S.C. on 18.3.2020 by email for postponing the scheduled date of the physical test, but the M.P.S.C. has not taken any decision thereon. Therefore he prayed to grant the interim relief as prayed for.

4. Learned Presenting Officer, on instructions, has submitted that already physical test is scheduled on 22.3.2020 at Amravati and 2 Committees have been formed by the respondent no. 4 the M.P.S.C. for conducting the tests. Each Committee has to conduct the physical test of about 40 to 50 candidates every day. She has submitted that at a time 4 to 5 candidates used to be called for the physical test. She has submitted that there will be no gathering of

persons in large number and therefore no question of postponing the scheduled date of physical test arises. She has submitted that in view of this the blanket order to stop the physical test scheduled from 20.3.2020 cannot be granted. She has further submitted that other candidates are appearing for the physical test, which is scheduled from tomorrow i.e. 20.3.2020 and they have not raised any grievance. Therefore she has prayed to reject the interim relief as prayed for by the applicants.

5. On perusal of record it reveals that the physical test for limited departmental examination for the post of P.S.I. has been scheduled from 20.3.2020. It seems from the record that 87 and more candidates are appearing for physical test on each day. Two Committees have been formed for conducting the physical test. The applicants have made representation to the respondent no. 4 the M.P.S.C. on 18.3.2020 through email to postpone the oral tests in view of the advisory issued by the Central Government and directions given by the Principal Secretary of the Public Health Department of Government of Maharashtra. would be appropriate to direct the respondent no. 4 the M.P.S.C. to take decision on the representation of the applicants dated 18.3.2020 sent by email, today itself in view of the advisory issued by the Central Government and the communication dtd. 15.3.2020 sent by the Principal Secretary, Public Health Department to the respondent no. 4 the M.P.S.C. and to communicate the decision thereon to the applicants.

7. The learned Presenting Officer is directed to communicate this order to the respondent no. 4 the M.P.S.C. immediately by email along with copy of representation of the applicants dtd. 18.3.2020.

8. Learned Advocate for the applicants has submitted that since this Tribunal granted the interim relief as above, the applicants do not want to proceed with the O.A. as the O.A. will be infructuous after 22.3.2020. Therefore he prayed to dispose of the O.A. at the admission stage itself.

9. In view of this the present O.A. stands disposed of with no order as to costs.

10. Steno copy allowed for the use of both the sides.
