ORDER

1. Heard Shri B.A. Bandiwadekar, learned Advocate for the Applicants and Shri A.J. Chougule, learned Presenting Officer for the Respondents.
2. Ld. PO states as follows:
 - (a) That the applicants' pension case is submitted to the office of Accountant General on 7.3.2017.
 - (b) Thereafter the matter was pursued to the AG's office by sending special messenger viz. Shri Shivaji Ayre, Assistant Mechanic.
 - (c) Reminder is also sent to the office of AG on 18.3.2017.
 - (d) The officers in the office of AG have orally informed that minimum one month's time would be required.
3. In case the office of AG is engrossed in processing the cases which are either decided by the Court or Tribunal or pending, in accordance with any particular sequence or order or modality, and that due to said

practice present applicants' case cannot be decided within one month, this Tribunal would ordinarily accept the point of view of the office of AG. However, if any such modality settled by the office of AG is not in vogue and is not brought to the notice of the Tribunal, grant of one month's time on random basis and sheerly for asking would amount to permitting departure from fairness.

4. Therefore, Accountant General, Mumbai is directed as follows:


- a) To communicate to this Tribunal through the office of Chief Presenting Officer as to what is the modality or practice adopted by the office of AG for processing the pension cases where the payment of pension is being processed consequent to an order in a case before Court or Tribunal.
- b) As to whether any special priority is given to the matters which are either decided or are pending before the Tribunal/Court.
- c) What is the maximum time required by the AG to decide present applicant's case?

5. Learned PO is directed to communicate this order to the AG, Mumbai.

6. Ld. PO requests that one week's time may be granted for informing this order and securing instructions.

7. Request is accepted and the hearing is adjourned to 31.3.2017.

Liberty is reserved for them to do so, if circumstances so warrant and bring any other appropriate action on the same cause of action.</p> <p>Notice was issued to the learned Advocate General because there was a challenge to a certain Government instrument. Mr. Jagdale told me that in view of the fact that he is restricting his relief only to the alternative prayer, that aspect of the matter no more remains at large. As far as the submission of the learned CPO made on the last occasion that this is a Division Bench matter, I find that in view of the prayer having been restricted to the alternative prayer only a Single Bench can make an appropriate order.</p> <p>The matter has been kept back for the learned CPO to appear. However, I do not think, I should wait any longer. Mrs. Gaikwad, the learned PO holds for the learned CPO.</p> <p>In view of the foregoing, this OA is disposed of with a direction to the Respondent No.2 to consider and decide the representation of the Applicant dated 15.5.2014 within six weeks from today and communicate the decision to the Applicant within one week thereafter. 3. The point as to the circumstances in which the matter has to go to the Hon'ble the Chief Minister for his approval is satisfactorily answered.






