Learned Advocate for the applicant has submitted that the applicant has been promoted on the post of Office Superintendent on 01.07.2017, as his earlier period of interruption in the service has been condoned by the Director, Medical Education and Research, Mumbai by the order dated 17.09.2016. He has submitted that accordingly, the applicant worked on the post of Office Superintendent since 01.07.2017. He has submitted that thereafter, the respondents have passed the order dated 24.02.2020 and cancelled

the order dated 07.11.2016 condoning the interruption in the service. On the basis of the said order, the Director, Medical Education and Research, Mumbai issued the order 16.03.2020 and cancelled the promotion given to the applicant on the post of Senior Clerk and posted at Jalgaon. Learned Advocate for the applicant has further submitted that the impugned order has been passed in view of the provisions of Rule 48(1) proviso (b) and (c) of the Maharashtra Civil Services (Pension) Rules, 1982. He has submitted that the applicant is going to retire on 31.07.2020. He has submitted that due to demotion of the applicant, the applicant has to work on the lower post and therefore, he has prayed to grant interim relief. He has submitted that the respondents have not interpreted the provisions of Rule 48(1) proviso (b) and (c) of the Maharashtra Civil Services (Pension) Rules, 1982 correctly and with proper perspective while passing the impugned order. Therefore, he has prayed to stay the impugned order.

5. Learned C.P.O. has submitted that earlier the Director, Medical Education and Research, Mumbai has passed the order condoning the interruption in service of the applicant in the year 2016, but the said

order was not in accordance with the provisions of Rule 48(1) proviso (b) and (c) of the Maharashtra Civil Services (Pension) Rules, 1982. Therefore, the Government has cancelled the order passed by the Director, Medical Education and Research, Mumbai. Consequently, the promotion given to the applicant has been cancelled by the impugned order. He has submitted that there is no illegality in the impugned order and therefore, he has prayed to reject the interim relief as prayed for the applicant.

6. On perusal of the record, it reveals that there was interruption in the service of the applicant for the period of 26 months and 22 days. The period of interruption exceeded one year, but the Director, Medical Education and Research, Mumbai has condoned the delay by the order dated 17.09.2016 without considering the provisions of Rule 48(1) proviso (b) and (c) of the Maharashtra Civil Services (Pension) Rules, 1982. Therefore, the Government cancelled the order dated 17.09.2016 by the order dated 24.02.2020. The applicant was promoted on the post of Office Superintendent after condonation of

interruption in the service. But the order of condoning the interruption has been cancelled on 24.02.2020 by the Government. Since his request for condoning the interruption in the service has been cancelled, the promotion granted to him has also been cancelled by the impugned order dated 16.03.2020. Prima-facie, there is no illegality in the impugned order and the impugned order has been issued by the respondents in view of the provisions of Rule 48(1) proviso (b) and (c) of the Maharashtra Civil Services (Pension) Rules, 1982. Therefore, in my view, it is not a fit case to grant interim relief as prayed for by the applicant. Hence, the request of the applicant to grant interim relief is hereby rejected.

7. Issue notices to the respondents, returnable on 28.04.2020.

8. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

9. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that
