2. Learned Advocate for the applicant has submitted that the applicant has been posted on the post of Block Development Officer (BDO) at Dhule in 2018 by order dated 16-08-2018. He has submitted that the applicant has not completed normal tenure of posting at the said place but he has been transferred by the impugned order from Dhule to Yavatmal in contravention of the provisions of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 ("Transfer Act" for short) as well as the Revenue Division Allotment of appointment by nomination and promotion to the posts of Group "A" and Group "B" (Gazetted and Non-Gazetted) of the Government of Maharashtra Rules, 2015. He has submitted that the applicant has not been yet relieved and nobody has been appointed on his post. Therefore, he has prayed to grant interim relief in his favour.

3. Learned C.P.O. has submitted the Government has earmarked some posts of BDOs for posting and appointment as Deputy CEO and Selection Grade BDO. He has submitted that the post of BDO, Dhule is earmarked for Selection Grade BDO and Deputy CEO in view of the G.R. dated 06-08-2016. He has submitted that the applicant cannot be posted on such post as he is not BDO Selection Grade. Therefore, the respondents have transferred him on administrative ground. He has submitted that there is no illegality in the impugned transfer order. Therefore, he has prayed to reject the prayer for interim relief.

4. On perusal of the G.R. dated 06-08-2016, it reveals that the post of BDO, Dhule has been earmarked for the appointment and posting of Deputy CEO and Selection Grade BDO. The applicant has entered the service in the year 2018. He is not in the cadre of Selection Grade BDO. Therefore, the respondents have made his transfer so as to appoint the eligible officer i.e. Deputy CEO or Selection Grade BDO at Dhule. Accordingly, the impugned order has been issued.

5. Prima facie, it seems that there is no illegality in the impugned order. Therefore, in my view, it is not a fit case to grant interim relief in favour of the applicant. Hence, prayer for interim relief is rejected.

6. Issue notice to respondents, returnable on 22.09.2019.

7. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

8. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
