Heard Smt. Vaishali Deshpande, learned Advocate holding for Shri A.S. Bayas, learned Advocate for the Applicant and Shri V.R. Bhumkar, learned Presenting Officer for the Respondents.

2. The Applicant has challenged the orders dated 19.10.2019 and 21.10.2019 respectively by filing the present Original Application. By order dated 21.10.2019, the request of the Applicant to condone the break of 2 years 2 moths and 26 days in service has been rejected. Prayer clause 'C' made by Applicant is based on order dated 21.10.2019. Therefore, there is no delay in filing the Original Application. Hence, the objection raised by the office is overruled.

3. Original Application be registered after due scrutiny. The present case is removed from board.

Heard Shri A.S. Deshmukh, learned Advocate for the Applicant and Shri V.R. Bhumkar, learned Presenting Officer for the Respondents.

2. Today, the Contemnor - Dr. Pradeep Vyas, Principal Secretary, Public Health Department is present and filed short affidavit. The same is taken on record.

3. On perusal of record it reveals that the Contemnor had taken decision in the matter of the Applicant in view of the order passed by this Tribunal on 30.01.2017 in O.A.No.210 of 2013 on 22.11.2018. Thereafter, he took decision on 06.02.2019 in view of the direction given by this Tribunal in C.P.No.57 of 2018 on 4.12.2018. Thereafter, he again took decision regarding entitlement of the Applicant to condone the break in service and for pensionary benefit by order dated 11.12.2019.

4. On perusal of the same it reveals that the Contemnor has taken decision belatedly in the case of the Applicant in view of the direction given by this Tribunal in O.A.No.210 of 2013. The Contemnor, who is present today has tendered unconditional apology for the delay caused for taking the decision. The unconditional apology tendered by Contemnor-Shri Pradeep Vyas, Principal Secretary, Public Health Department is accepted.

5. On perusal of above said orders and order passed by this Tribunal it reveals that Contemnor was directed to consider the circumstances mentioned in the order passed by this Tribunal in O.A.No.210 of 2013 and to take decision as per the provisions of Maharashtra Civil Services (Pension) Rules, 1982. On perusal of the said orders, it reveals that the Contemnor as well as the Government has not considered the Rule 4 read with Rule 48 of M.C.S. (Pension) Rules, 1982 and other relevant provisions while deciding issue regarding condonation of the break in the service of the Applicant while taking above said decision.

6. At this stage, Contemnor-Shri Pradeep Vyas, Principal Secretary, Public Health Department has submitted that he is going to consider the case of the Applicant afresh in the light of the observations made by this Tribunal in O.A.No.210 of 2013 and also consider the case of the Applicant in view of Rule 4 of the M.C.S. (Pension) Rules, 1982 and will take
