3. Today, the learned P.O. has produced on record the communication dtd. 21.11.2017 received from the Under Secretary of Govt. of Maharashtra stating that the Government is taking proper steps to give posting to the applicant and till then said period will be considered as waiting period and duty period. It is taken on record and marked as document 'X' for the purpose of identification.

4. On going through documents, it appears that the res. nos. 1 to 3 have not verified the correct position of the vacancy of the post at S.R.P.F., Group no. 3, Jalna while making transfers of the Medical Officers and they have posted the res. no. 5 in place of the applicant, though the applicant was working there and not due for transfer as he has been transferred at that place in April, 2017. No transfer order transferring the applicant from S.R.P.F., Group no. 3, Jalna has been issued by the res. nos. 1 to 3 till today but he has been relieved from that post by res. no. 4 on 12.10.2017. Since then the

applicant is waiting for his posting. Now the Government is intending to treat the absentee period of the applicant as a waiting period / duty period. The entire things happened because of non application of mind by the concerned Officer of the Public Health Department while making the transfers. The Govt. is required to pay salary to the applicant though he is not rendering the services.

5. In the circumstances, in my view, this is nothing but waste and loss to State exchequer of public money. Therefore, the res. no. 1 the Principal Secretary, Public Health Department, Mumbai is directed to make an enquiry as to who is responsible for the said mess for effecting the transfer of the applicant & not giving posting to the applicant and take necessary action against the said Official and to file his personal affidavit in that regard on the next date.
