2. The applicants have challenged the advertisement dated 3.1.2019 (Annex. A.1) of the post of Krushi Sevak issued by the res. no. 3 for Pune region. It is contention of the applicants that the standard of examination for the said recruitment so far as subject of Agriculture is concerned, it should be of Agriculture Diploma level, but the respondents have set the question papers containing the questions of degree level and therefore injustice has been caused to the applicants, who are Diploma holders. The applicants have submitted sample questions, which are coming under degree level course (page 40 & 41).

3. Learned Presenting Officer has submitted that all the questions i.e. 120 questions for Agriculture subject were up to the level of Agriculture Diploma level and none of the question is from Degree level.

4. During the course of hearing the learned Advocate for the applicants as well as learned Presenting Officer have submitted that in order to resolve the controversy regarding standard of questions so far as subject of Agriculture, it is necessary to refer the question papers to the Expert Committee to submit their report as to which questions were up to the Diploma level or as to whether any question is included from the Degree level.

5. Learned Advocate for the applicant and learned Presenting Officer suggested the name of Expert Committee as under :-

‘The Director General, Maharashtra Council of Agriculture Education & Research, Pune.’

6. In view of above submissions of both the sides, it is just to refer five set of question papers containing 120 questions in each of agriculture subject to the Director General, Maharashtra Council of Agriculture Education & Research, Pune to verify as to whether the questions so far as subject of Agriculture is concerned were of Diploma level or beyond the syllabus of Diploma level and submit the report before the Tribunal within a period of two weeks.

7. Learned Presenting Officer has submitted that she has produced the entire original record regarding recruitment of all individuals in the Registry as per the

directions of the Tribunal. She has submitted that at this stage the said original record is not required. In the circumstances, she prayed to return the said record to the respondents. Learned Advocate for the applicants has no objection to return the said record.

Learned Presenting Officer has submitted that this Tribunal has granted interim relief in favour of the applicants in Original Application vide order dtd. 13.3.2019 and directed the respondents not to prepare the final select list unless specific permission is sought from this Tribunal. Learned Presenting Officer has submitted that there are eight Agriculture Divisions in the State of Maharashtra including the Pune Division. She has submitted that each of the Division has issued separate Notification / advertisement for the recruitment of the post of Krushi Sevak available in the respective Divisions and accordingly the examinations have been conducted. The applicants have challenged the advertisement dated 3.1.2019 issued by the res. no. 3 the Divisional Joint Director of Agriculture, Pune for filling up the post of 313 Krushi

Sevaks in Pune Division. She has submitted that blanket interim relief was granted by the Tribunal vide its order dated 13.3.2019 and therefore the recruitment process of all eight Divisions is stalled. She has submitted that the grievance of the applicants is regarding 330 posts only in Pune Division. Therefore, she prayed to modify the said interim order. She submits that nobody from other Divisions have raised grievance about the recruitment process conducted in those divisions and therefore it is just to make it clear that the interim relief granted by the Tribunal vide order dtd. 13.3.2019 is applicable to the Pune Division only and not to the recruitment process in other Divisions and therefore she prayed to modify the impugned order.

3. Learned Advocate for the applicants submits that the applicants have grievance about recruitments of Pune & Latur Divisions and therefore he prayed to pass the necessary orders.

4. On perusal of prayer clauses made by the applicants in the Original Application it reveals that the applicants have challenged the advertisement dated 3.1.2019 (Annex. A.1) regarding recruitment of Krushi Sevak in Pune Division only and therefore it will be just to grant the interim relief in favour of the applicants to that extent only.

5. In view of this, the earlier order of interim relief dated 13.3.2019 passed by this Tribunal is modified and the respondents are directed not to prepare the final select list so far as recruitment process of Pune Division is concerned.

6. Accordingly the misc. application is disposed of without any order as to costs.
