9. Facts which are glaring are as follows:

(a) Suspension of the applicant has been ordered on 14-11-2017.

(b) Departmental enquiry towards any misconduct has not commenced, though for more than 19 months suspension is continued by neglect.

(c) Any order based on conscious decision for continuing the suspension is not passed.

(d) In view of the judgment delivered by Hon'ble Supreme Court in Ajaykumar Chaudhari's case and followed in various judgments of this Tribunal, continuation of suspension in absence of conscious decision is prima facie impermissible.

10. Hence, this Tribunal is satisfied that the present is a fit case for grant of interim relief by way of stay of suspension.
