3. The applicant is working as a Tracer with the respondents. He has passed a Diploma in Civil Engineer and, therefore, he claims that he should be promoted to the post of Jr. Engineer (Civil). The applicant relies on the decision of principal seat of this Tribunal at Mumbai dtd. 6.11.1992, in T.A. no. 1715/1991

(W.P. no. 6007/1986) and decision dtd. 16.11.1992 in T.A. no. 200/1991 (W.P. 1987/1987), wherein it was directed that the promotion of some of Tracers to the post of Jr. Engineer shall be reinstated as those applicants were relegated to the post of Tracer.

4. The respondents have clarified that the case of the applicants in above referred T.As. is different from the case of the present applicant. Those applicants were governed by the Recruitment Rules, which were in existence at the time of their initial promotion. The present applicant is admittedly appointed as a Tracer in the year 1994 and for promotion from the post of Tracer now the respondents have fresh Recruitment Rules viz. Junior Engineer (Civil) Group 'B' 'non-gazetted in the Public Works Department and the Irrigation Department (Recruitment) Rules, 1998. The said Recruitment Rules inter-alia provides that for promotion to the post of Junior Engineer (Civil), the feeder cadre is Civil Engineering Assistant and the employee, who has passed the qualifying examination for the post of Junior Engineer conducted by the Engineering Staff College, Nashik and, therefore, the present applicant cannot be promoted.

5. The decision of the principal seat of this Tribunal at Mumbai in T.As. on which the

learned Advocate for the applicant has placed reliance has been explained by the respondents in their affidavit in reply vide para nos. 2 & 3 by referring to the earlier Recruitment Rules and the fact that those applicants, who were promoted to the post of Overseer (post then available), were relegated to their earlier post of Tracer as they have crossed the upper age limit and, therefore, the Tribunal has directed the respondents to reinstate them on the post of Jr. Engineer (Civil) as renamed at that time.
