2. Learned Advocate for the applicant has submitted that the applicant was due for transfer at the time of general transfers of the year 2019 but that time one year's extension was given to him. He has submitted that by the impugned order dated 19-08-2019, the applicant has been abruptly transferred on administrative ground to accommodate the respondent no.4. He has submitted that provisions of the Maharashtra Government servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 ("Transfer Act" for short) have not been followed while issuing the impugned order. He has submitted that the impugned order is in contravention of the provisions of the Transfer Act. The applicant has not yet been relieved from the present post and he has been deputed at Nashik for official meeting. He has produced communication dated 23-08-2019 in that regard. He has submitted that the respondent no.4 is trying to take charge of his

post in the absence of the applicant. Therefore, he has prayed to grant interim relief in favour of the applicant.

3. Learned P.O. submits that she wants to file detailed reply as she has no instructions from the respondents in the matter. She has submitted that the impugned order has been issued as per S.4(4) and 4(5) of the Transfer Act. Therefore, she has prayed to reject the interim relief.

4. On perusal of record, prima facie it seems that the impugned order is not in accordance with the provisions of the Transfer Act. The applicant has not been relieved from the post. Therefore, respondents are directed not to relieve the applicant till next date.

5. Issue notice to the respondents, returnable on 30-09-2019.

6. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

7. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

8. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal

(Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

9. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

10. If notice is not collected within 7 days or proof of service is not produced before 3 days of the next date, case shall automatically stand dismissed without further reference to the Tribunal.
