2. By the present M.A. the applicant is seeking condonation of 6 years and 7 months delay caused in filing accompanied O.A.

3. The accompanied O.A. has been filed by the present applicant since he was terminated from the post of Clerk. He was appointed on compassionate ground. However, since he could not pass the requisite typing examination within a period of 2 years, he came to be terminated by the impugned order dtd. 26.8.2010 (Exh. G page 20 in OA).

4. The present applicant claims that in view of G.R. dtd. 8.9.1997 (Exh. H page 21 in O.A.), he still can be appointed in Group - D category as it is provided in the said G.R. that, whose services are terminated in the circumstances mentioned hereinabove, he can be considered for appointment in Group - D category.

5. Regarding delay caused in filing accompanied O.A., the present applicant submits that since he was

making representation after representation for his grievance, he did not file O.A. assuming that the concerned authority would act on the G.R. dtd. 8.9.1997 (Exh. H page 21 in OA). He submits that his mother is old aged and also bedridden and the applicant was busy in taking care of his old aged mother and, therefore, delay occurred in filing the O.A.

6. Learned P.O. submits that there is inordinate delay in filing the O.A. and the same may not be condoned.

7. Upon hearing both the sides, in my opinion, the delay caused in filing accompanied O.A. is properly explained. In the circumstances, the present M.A. is allowed and disposed of without any order as to costs and delay of 6 years and 7 months in filing accompanied O.A. is hereby condoned.

8. Office to register the O.A. on due scrutiny.

9. Upon registration, the O.A. may be circulated for further hearing.
