





The Applicant retired as a Lecturer in Sir J.J. School of Mumbai on 31st January, 2013 and somehow or the other, the issue regarding his post retiral benefits have been hanging fire till date which ought not to have been the state of affairs. I am informed on behalf of the Respondents that the provisional pension of the Applicant right till June, 2017, full payment of GPF and Group Insurance, amount have been paid to the Applicant. Regular pension and gratuity have not been paid. There is some reference to a certain G.R. dated 27th February, 2017. In the Affidavit-in-rejoinder, there are averments to the effect that the said GR cannot stand judicial scrutiny but in as much as that GR has been brought into existence, when this OA was already pending, it has naturally not been formally challenged in the OA. The Applicant shall be allowed to formally challenge it by way of an appropriate application because in that event, the notice may have to be issued to the learned Advocate General. However, instead of theories and academic discussions, it will have to be closely examined as to whether that GR will be applicable at all in case of the Applicant because as on the date of his retirement, that GR was nowhere in sight and the issue of his post retiral benefits will have to be considered on the basis of the various instruments that were actually in force on the date of his retirement. The learned PO assures that, within two weeks, she would take necessary instructions and do the needful. I make it clear that, nobody is going to benefit from the pointless academic discussions and on hard facts, it must be examined as to whether this matter can be decided finally at the earliest.

With all these observations, the matter stands adjourned to 11th August, 2017. Hamdast.
