The applicant has challenged the impugned order dated 21.08.2019 issued by the respondent No. 3 and directed the applicant to handover the charge of the post of District Sports Officer, Ahmednagar to one Shri Vijay Bapurao Santan, District Sports Officer, Pune, by filing the present Original Application.
3. Learned Advocate for the applicant has submitted that the impugned order has been issued by the respondent No. 3 on the basis of the Government letter dated 21.08.2019 without assigning any reason. He has submitted that the applicant has not transferred from the post and therefore, he has prayed to stay the operation and execution of the impugned order. He has further submitted that the applicant has not handed over the charge of the post of District Sports Officer, Ahmednagar and therefore, he has prayed to protect the applicant by granting interim relief.

4. Learned Presenting Officer has placed on record a copy of communication dated 22.08.2019 of Shri Vijay Santan to the Commissioner, Directorate of Sports, M.S., Pune, stating that he took the charge of the post of District Sports Officer, Ahmednagar on 22.08.2019. He has submitted that there were several complaints of serious nature against the applicant regarding her work from the Teachers and the peoples representative with the concerned Minister and therefore, the impugned order has been passed and the applicant is directed to handover the charge of the post of the District Sports Officer, Ahmednagar to Shri Vijay Santan, District Sports Officer, Pune, considering the seriousness in the allegation made against him. He has submitted that already Shri Vijay Santan has taken over charge of the work of the applicant and therefore, no question to grant stay to the impugned order arises. Therefore, he has prayed to reject the interim relief as prayed for by the applicant.

5. On perusal of the record, prima-facie, it reveals that on the basis of the complaint received from the Teachers and the peoples representative with the concerned Minister regarding functioning and behavior of the applicant, the respondents have passed the impugned order and made temporary arrangement of handing over the charge of the post of District Sports Officer, Ahmednagar to Shri Vijay Santan, District Sports Officer, Pune. According to the District Sports

Officer, Pune, he took the charge of the post of the District Sports Officer, Ahmednagar on 22.08.2019. The impugned order has already been implemented and therefore, in my view, no question of granting stay to the same arises. Hence, the interim relief as claimed by the applicant is hereby rejected.

6. Issue notices to the respondents, returnable on 27.09.2019.

7. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

8. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

9. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

10. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

11. If notice is not collected within 7 days or proof of service is not produced before 3 days of the next date, case shall automatically stand dismissed without further reference to the Tribunal.
