3. It would appear from the decision in O.A. Nos. 134, 135 & 136 of 2010 dated 29.09.2010 (Exhibit- L, page no. 52) that this Tribunal at Principal Seat at Mumbai has decided the issue that has arisen in the present O.A. The issue is as to whether the ad-hoc promotion is to be computed for the purposes of benefit of Assured Career Progression Scheme. The Division Bench has allowed the said O.As. The page No. 67 would show that the State was aggrieved by the said decision and therefore, the State has filed W.P. No. 901/2011 & 904/2011, on 27.06.2011 the Hon'ble High Court of Bombay has granted interim stay to the operation of the decision of the Division Bench of the Maharashtra Administrative Tribunal,

Mumbai, was granted. However, now vide decision dated 12.10.2017, the Hon'ble High Court of Bombay has disposed of the said W.Ps. on the basis of tendering the letter by the respondent State dated 12.10.2017, which was marked as 'X' for the purposes of identification by the Hon'ble High Court of Bombay. This decision would show that the respondent State has taken certain decision, which was communicated to the Hon'ble High Court vide above referred letter and therefore, the W.Ps. came to be disposed of. Copy of the said decision is received by the learned Presenting Officer.

4. Learned Presenting Officer is directed to take instructions from the concerned respondent as to what decision was taken and also secure copy of the letter dated 12.10.2017, which was filed in W.P. Nos. 901 & 904 of 2011 and file the same on record on the next date.
