2. The Caveator undertakes to serve a copy of this Caveat upon the Caveatee by Registered Post A.D.

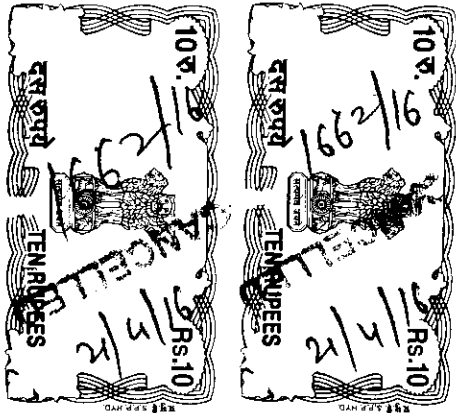

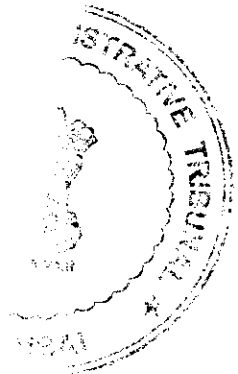
