The Office will function with attendance of 50% of Officers and Staff. The Officers and Staff Members will be called as and when necessary and required as per the directions of the Hon'ble Chairperson.

During the above Court working days only concerned Advocates will be allowed to attend the Court by way of necessary precautions. No Litigant will be


allowed to enter the premises of the Maharashtra Administrative Tribunal, Mumbai
'STRICTLY'.

All the Advocates, Litigants, Party-in-Person are further informed that due to their absence on the date of hearing no matter will be dismissed.

This arrangement is made subject to the COVID-19 Pandemic situation and further guidelines issued by the Government of Maharashtra.
