CIRCULAR

All the Advocates, Litigants, Party-in-Person, Office of the Chief Presenting Officer, Officers and Staff Members of the Maharashtra Administrative Tribunal, Mumbai are hereby informed that, to combat the rising COVID-19 cases, Government of Maharashtra in the Department of Revenue and Forest, Disaster Management, Relief and Rehabilitation, Mantralaya, Mumbai has issued order dated 29.04.2021 to Break the Chain of rising COVID-19 cases, the said order containing imposition of various emergency measures seeks to prevent and to contain the spread of the virus.

(subject to the prevailing COVID-19 situation in Mumbai and Maharashtra).
