C I R C U L A R

- (A) Constitution of Single Member Bench of the Tribunal to dispose of specified cases.
- (B) In exercise of the powers conferred by sub section (6) of Section 5 of the Administrative Tribunals Act, 1985 and in modification of all earlier orders issued in this behalf, I Justice A.H. Joshi, Chairman, Maharashtra Administrative Tribunal hereby authorize all the Vice-Chairmen and the Members of the Maharashtra Administrative Tribunal, to function as to a Bench consisting of Single Member and to exercise the jurisdiction, powers and authority of the Tribunal in respect of such cases or class of cases as are specified below with effect from 1st February, 2016 :-



- (C) All the cases specified above which are pending admission/ hearing will be posted for admission and hearing before the Single Bench.
- (D) If the Single Member hearing cases liable to be heard by the Division Bench is of the view that any case is not fit for admission Single Member will make such interim order as the Single Member may deem fit and post as soon as may be the case before the Bench of two Members.
- (E) If at such stage of hearing of any such case or matter, if it appears to the Hon'ble Chairman or such Single Member that the case or matter involves substantial question of law or interpretation of Constitutional Provision or is

of such nature that it ought to be heard by a Bench consisting of two members, they may refer the case or the matter to a bench consisting of two members subject to the provision as contemplated under Section 5 of the Administrative Tribunals Act, 1985.

- (F) The Bench of Single Member shall be constituted in the course of Principal Bench by the Hon'ble Chairman and in the absence of the Hon'ble Chairman by the Hon'ble Vice-Chairman of the Principal Bench & in case of other Benches i.e. Nagpur and Aurangabad subject to the Hon'ble Chairman's approval by general or special order by the Hon'ble Vice-Chairman of the concerned Bench.
