This proposal is made by the Director , Health Services, Mumbai to the Govt. It is worthwhile to note that the O.A. No.879/2012 was filed by the Attendants serving in the

Mumbai Region seeking the same relief and the Principal Bench of the Tribunal at Mumbai vide the order dtd. 9/1/2013 disposed of the O.A. with the direction “ Having regard to the aforesaid facts and circumstances, the Respondent No.1 is directed to take a decision with regard to the said proposal of Respondent No.2 dated 25th January, 2012 with regard to grant of higher pay scales to the Applicants for working as Attendants in the Mental Hospital, preferably, within a period of three months from today-----
--.”

As such Ld. P.O. strongly opposed on the ground that the relief is already granted by the Mumbai Bench and hence the O.A. is not tenable. The Id. Counsel for the applicant submits that the applicants are from the Nagpur Region. However, the direction is applicable to over all Maharashtra and as such it is not necessary for the applicant to file the separate O.A. again seeking the same relief.

However the Id. Counsel for the applicant submits that the applicants have remedy to get the said order implemented. Ld. C.P.O. submits that the proposal (Anne.A-5,page-31) is made on the basis of the representation moved by the Association vide communication dtd. 18/11/2011, as such the applicants can agitate the matter through their Association. The Id. Counsel for the applicant submits that no fruitful purpose is served and now the applicants' Union may not initiate the contempt proceedings.

In the above state of affairs, the O.A. is disposed of with direction on the above lining to R/1 to decide the said proposal within a month from the date of receipt of this order. With this direction the O.A. is disposed of.

At this stage such submission cannot be accepted because to meet the exigency for the smooth administration, the Department can make such time being arrangement so as to have the smooth working. However, at present there is no material on record to consider such aspects.

In the above state of affairs status-quo as on today be maintained in respect of the applicant till filing of the reply.
